PLEASE READ AND INITIAL BY EACH OF THE RANGE RULES, THEN SIGN AND DATE AFTER LIABILITY RELEASE.

- ___ 1. Eye and ear protection must be worn at all times.
- ___ 2. Drug and alcohol use is strictly prohibited.
- ___ 3. All rental firearms entering or leaving the range area must be UNLOADED with actions open and gunlock or barrel properly secured.
- ___ 4. Personal firearms must be unloaded and cased, or with current CCP, holstered and concealed, until at station on the range.
- ___ 5. Firearm muzzles must be pointed downrange at all times and **NEVER HIGHER THAN THE TARGET.**
- ___ 6. Unaimed and uncontrolled fire is strictly prohibited. All shots must be fired at approved targets. Any shots striking an overhead baffle will result in a ten-dollar (\$10.00) fine. Failure to report such an incident may jeopardize your registration with the Range.
- ___ 7. **Only handgun caliber ammunition allowed.** (2000 ft per sec max velocity) Rim-fire ammunition permitted.
NO CENTER FIRE RIFLE CALIBERS ALLOWED AT ANY TIME.
- ___ 8. **ONLY JACKETED AMMUNITION ALLOWED.** NO lead or cast bullets may be fired at anytime. (Exception: .22 cal. Rim fire non-jacketed ammunition or with prior permission from Firing Line Staff.) Or Russian Manufactured **ABSOLUTELY NO ARMOR PIERCING AMMUNITION ALLOWED. ALSO, NO WOLF AMMUNITION ALLOWED.**
- ___ 9. **RELOADED AMMUNITION MUST HAVE JACKETED BULLETS.** Reloads will be inspected prior to use on range.
- ___ 10. Only Range ammunition is to be used in Range rental firearms.
- ___ 11. Only one person may fire from a booth at a time.
- ___ 12. **NO RAPID FIRE.** One-second rule applies. (1 round per second)
- ___ 13. **NEVER** cross the firing line or proceed in front of the barriers.
- ___ 14. **NO** food or beverages are allowed in the Range area.
- ___ 15. Brass may be retrieved but only the amount you brought into the range.
- ___ 16. Please remove and dispose of all debris when leaving the Range.
- ___ 17. Please insure when entering the Range that the outer door is closed prior to opening the inner door. This will help keep the noise out of the lobby.
- ___ 18. **NO** handling of firearms by customers at anytime except when on the firing line at their assigned shooting position or when assisted by Firing Line Staff. Shooters may trade lanes to try other firearms.
- ___ 19. Any shooter under the age of 18 must be supervised by a parent or guardian and must have proof of completion of a Hunters Safety or Basic Handgun Course. Minimum Age 12 Yrs Old
- ___ 20. **ANYTIME A CEASE FIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY FROM THE FIRING LINE IMMEDIATELY.** Any shooter is allowed to call a cease-fire for any safety violation, anytime.
- ___ 21. **FIRINGLINE INDOOR GUN RANGE EMPLOYEES HAVE UNQUESTIONABLE AUTHORITY REGARDING THE OPERATIONS OF THE RANGE.**
